Services include owning and managing housing units; processing rental subsidies; community and coalition building.

4b (Code:) (Expenses \$ 240,271. including grants of \$) (Revenue \$) Advocacy program services are delivered via telephone, in the association's offices, at community mental health centers, and in various other places. Activities range from offering individuals encouragement, support, and referral assistance to intervention and mediation. Advocacy requests frequently concern housing, treatment, food or employment assistance.

Community education increases public awareness and knowledge of mental illness and its treatment, and reduces the related stigma. The Agency offers affordable seminars, lecture series for consumers and family members, and continuing education credits for professionals.
